• Principal's Report- Dr. Waldrop

1. Device Update: Marshall was given 106 additional laptops from the county available to families right now (already given almost 300 to students)

- 2. School division has committed to getting every student a laptop by the end of January.
- 3. PWCS (not school-level budget) purchased for teachers: over-the-head Bluetooth headset and "selfie stick" camera to teach in-person and virtual simultaneously.
- 4. At Marshall: 60% in-person, 40% virtual projection for 50/50 return to learn. 639 students total enrolled.
- 5. Our priority is to keep children with their classroom teachers and keep teachers in their current position.
- 6. House A: Last names A-K (T/TH in-person).
- 7. House B: Last names L-Z (W/F in-person).
- 8. Marshall classrooms can hold approximately 12 students. Not expected to be at capacity in homerooms.
- 9. Sky Eagle donating 800 masks for our school. Thank you.
- 10. "Tier 1" health concern staff members may not be eligible to return in person.
